



<b>Nomination Period</b>	April 1st to May 23rd, 2025
<b>Application Period</b>	April 14th to May 30th, 2025
<b>Confirmation of Application<sup>1</sup> (Acceptance letter)</b>	June 14th
<b>Arrival date (suggestion)</b>	Between July 28th and August 3rd, 2025

<sup>1</sup> If at least one subject is accepted by the course coordinator(s), the student will receive the Letter of Acceptance to apply for the visa by email. According to new Brazilian regulations, the minimum working hours to be completed by exchange students must be fifteen/15 hours per week. Therefore, we suggest that all students recommended by their home universities choose as many subjects as possible, among those that interest them, so that they can be accepted in three or four of them, in order to obtain the minimum course load required by Brazilian legislation.

<b>Student Nomination and Application</b>	
<b>Nomination - procedures</b>	Students must be nominated by their home institution at <a href="#">nomination forms</a> (Only from April 1st, 2025).
<b>Application - procedures</b>	Students must also register online on the DAC (Academic Board) website, in the <a href="#">SIGA</a> .
<b>Language Requirements</b>	Unicamp does not have knowledge requirements in Portuguese. All Undergraduate level classes and most Postgraduate classes are offered in Portuguese. Exchange students are offered Portuguese classes in English and Spanish.

<b>Areas with Restrictions</b>	<ul style="list-style-type: none"><li>● <b>Medicine:</b> Only observational internships with a maximum duration of 90 days are allowed. Theoretical or practical courses do not accept enrollment of foreign students. For further information, please visit: <a href="https://www.fcm.unicamp.br/fcm/international-office">https://www.fcm.unicamp.br/fcm/international-office</a></li><li>● <b>Music:</b> Only for music course students, especially instrument classes.</li><li>● <b>Art courses:</b> Only for art students.</li><li>● <b>Sports Courses:</b> For sports course students only.</li><li>● <b>Thesis and final projects:</b> most departments do not accept students for theses and final projects, even though no exams are required.</li><li>● <b>Language courses:</b> Only Portuguese for foreigners or Portuguese for Spanish speakers, and ONLY if the student takes the placement test before the start of classes.</li></ul>

Course offers	Exchange students can request classes at all faculties and institutes, respecting the restrictions described above.  Class schedules (undergraduate and graduate) are available <u>here</u> . If the

appropriate semester schedule is not yet available, students must choose their classes based on the same semester of the previous year.

Classes are offered on four different campuses in three different cities. We strongly recommend that students take classes in only one city. The main campus is located in Campinas. Faculty of Applied Sciences (FCA) and Faculty of Technology (FT) are located in the city of Limeira and Faculty of Dentistry of Piracicaba (FOP) is in the city of Piracicaba.

### Credits / Hours

Undergraduate and Graduate students from Partner Universities can enroll for up to 32 credits per semester.

At UNICAMP, each credit corresponds to 15 class hours, lasting 15 (fifteen) weeks of class activities (readings, laboratory, etc).

So:

- A credit course = 15 hours
- A 4-credit course = 60 hours of academic activity per semester
- A student taking 24 credits will have a total of 360 hours of academic activities in that semester.
- There is no official equivalency between Credits at UNICAMP and ECTS.
- **ALL EXCHANGE STUDENTS** must have at least 15 hours (15 credits) due to a federal police legislation for regularizing the visa.

<b>Visa</b>	<p>To enroll at UNICAMP, a Student or Mercosur Visa is required, which can be obtained at the consular office of the Embassy or Consulate of Brazil in the student's country of origin. The visa must be applied for sufficiently in advance to allow time for bureaucratic procedures, which can be quite lengthy.</p> <p>While it is possible for students from some countries to arrive in Brazil as tourists and change their visa status while in the country, this is not recommended as this procedure requires a series of legalized and translated documents. Therefore, we strongly advise students to enter Brazil with a Student or Mercosur Visa.</p> <p>We strongly recommend that when applying for a visa at the Brazilian Embassy or Consulate in your country of origin, the student also requests the issuance of a document called CPF. This is an individual document necessary for operations such as opening bank accounts and registering for some public and private services, and it will certainly be requested at some point during your stay in Brazil.</p>
<b>Health Insurance</b>	<p>Health insurance is mandatory for all foreign students, and a copy of this document must be delivered to DAC via the system. The insurance must cover medical and repatriation expenses from the day the student leaves the country of origin. The choice of specific travel insurance is the responsibility of the student. If the foreign student arrives in Brazil without previously contracted</p>

health insurance, he will have to contract the insurance with a local agency.

UNICAMP has a community health care center called Cecom, which offers medical and dental consultations, in addition to emergency care. It also has two hospitals on the Campinas campus that can be used in urgent and emergency situations, especially on weekends, when Cecom is closed. Both services can only be used after registration has been completed (after the first two weeks after the start of classes).
